1. Pursuant to Section 15(1) of the Gas Act (Cap. 116A), SembCorp Gas Pte Ltd is hereby notified that the Gas Importer (PNG) Licence (Licence No. EMA/GI/004) ("Licence") is modified as follows:

- (a) Paragraph 3 of "Condition 1: Interpretation and Definitions" within "Part 2: General Conditions of the Licence" is modified by inserting the following definition of "End User" after the definition of "Electricity Act" and before the definition of "Existing Gas Sales Agreement":

"End User" means any person who has entered into an agreement with the Licensee, under which the person purchases (or is obliged to purchase) natural gas imported under the Licence from the Licensee;"; and

- (b) "Part 2: General Conditions of the Licence" is modified by adding, after "Condition 13: Provision of Information and Data of the Authorised Business", the following Conditions:

(i) **"Condition 14: Replacement Gas Supply"**

1. Where a force majeure event under the Licensee's Gas Sales Agreements is anticipated to cause natural gas supply by the Licensee to an End User to be disrupted for a period lasting seven (7) calendar days or more, the Licensee shall, within two (2) calendar days from such event occurring, make reasonable offers for replacement gas supply to the End User. If such offers are accepted by the End User, the supply of replacement gas shall commence within seven (7) calendar days of the disruption."; and

(ii) **“Condition 15: Prohibition of Gas On-selling Restrictions and Anti-Competitive Agreements, Decisions or Concerted Practices**

1. The Licensee shall not do anything to prevent, restrict or distort competition in any LNG and/or gas market in Singapore.
2. Without prejudice to the generality of paragraph 1, the Licensee shall not, without the prior written approval of the Authority, enter into or be a party to any agreement or decision or engage in any concerted practice that:
  - a) seeks to limit the number of suppliers that an End User may procure LNG, regasified LNG and/or gas from;
  - b) impose adverse consequences on an End User if the End User contracts with any other person for the supply of LNG, regasified LNG and/or gas in Singapore by that person to the End User;
  - c) prevent, restrict or impose adverse consequences on an End User if the End User on-sells LNG, regasified LNG and/or gas to any other person; or
  - d) prevent or restrict the on-selling of LNG, regasified LNG and/or gas to or by the Licensee in Singapore.

Nothing in this paragraph shall apply to any agreement which the Licensee was already a party to and which was already in effect prior to 23 November 2018.”.

2. This Notification shall come into effect on the date set out below.
