



## Singapore Energy Award 2019

### Nomination Form

#### **NOMINATION GUIDELINES**

1. **Objectives** – The Singapore Energy Award (SEA) is a biennial award that aims to recognise significant contributions to Singapore's energy sector\*, in the areas of **capabilities development** and/or **innovation**.

*\*The energy sector includes, but is not limited to, the power utilities and oil and gas sectors, as well as emerging sectors such as energy efficiency, and clean and renewable energy.*

2. **Award Categories** – There are **four** award categories for SEA 2019:

- a) **Singapore Energy Award for Capabilities Development** – Recognises outstanding **organisations** that have demonstrated strong and sustained efforts in nurturing a competitive, Singaporean-core workforce with the relevant skill sets for Singapore's energy sector.
- b) **Singapore Energy Award for Innovation** – Recognises outstanding **individuals** for their specific and sustained contributions to drive technological and business innovations in Singapore's energy sector.
- c) **Singapore Energy Award for Contributions to the Energy Sector** – Recognises outstanding **organisations and individuals** for their overall contributions to Singapore's energy sector.
- d) **[NEW] Singapore Energy Award for Youths** - Recognises outstanding **youths (35 years and below)** for their overall contributions to Singapore's energy sector.

The SEA welcomes nominations from: public and private sector organisations/companies; educational/research/training institutions; and individuals (e.g. entrepreneurs and professionals from the energy sector).

3. **Assessment Criteria** - All nominations will be evaluated according to the following criteria:

- a) **Establishing benchmarks and/or models in growing relevant talent pool and/or enabling research translation.**  
- Clear articulation of the benefits to the local energy landscape and/or wider society; shaping future initiatives relevant to Singapore; and receiving recognition from local and/or international bodies.

- b) **Exhibiting outstanding leadership and governance in driving manpower efforts and enabling research translation that benefits Singapore's energy landscape.**
  - Spearheading the development and implementation of strategies, policies or technologies to drive capabilities and/or research translation in Singapore; and investing resources to bring about transformational and sustained benefits to Singapore.
- c) **Sharing of knowledge that benefits industry stakeholders and/or wider society.**
  - Involving and inspiring industry peers and/or stakeholders to develop and/or adopt initiatives; and bringing about benefits to the local energy landscape and/or wider society.
- d) **Demonstrating successful implementation, taking into account scalability and sustainability of manpower initiative(s)/research outcome(s).**
  - Effectively addressing needs in the local energy landscape and/or wider society; implementing initiatives with scale-up potential; and rolling out cost-effective and easily adoptable technologies.

4. **Assessment Process** – All nominations will be subject to a rigorous selection process culminating in the selection of award recipients(s) by a Judging Panel, which comprises a carefully considered selection of representatives across various disciplines.

5. **All nominations should include Annex A duly completed.** This includes a **citation (refer to Annex A, Section 3)** to support the nomination and how it merits consideration for the Award.

6. Both **self- and third-party nominations** are welcome.

7. **No changes/modifications** to nominations are allowed **after submission**. The SEA Secretariat reserves the right to disqualify any nomination deemed to be incomplete or inaccurate.

8. The SEA Secretariat may make additional requests for information, site visits and/or /interviews, where necessary.

9. Nominations for SEA 2019 are open from **31 October 2018 to 26 April 2019**. Nominations can be submitted via the following methods:
