He led the delivery of several key infrastructure projects, such as the Thomson-East Coast Line Phase 1, Mandai Depot and the new Lornie Highway.</p> <p>Mr Ngien has more than 15 years of experience in the fields of maintenance, engineering, logistics and operations, including major rail infrastructure planning and projects implementation.</p> <p>He graduated from the National University of Singapore with a Master of Science in Industrial and Systems Engineering in 2004. He was conferred the Public Administration Medal (PPA) (Silver) in 2015 and PPA (Silver) (Military) in 2007.</p> <p>He currently serves on the Boards of the Urban Redevelopment Authority of Singapore (until 31 March 2021) and ST Logistics. 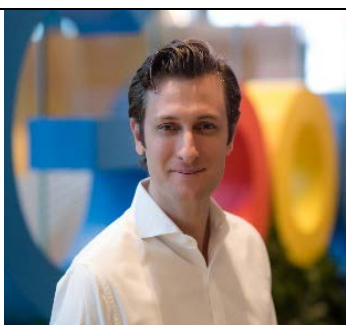
